<b>INCIDENT DESCRIPTION</b>	Dispatch received an emergency phone activation from the light rail platform; dispatch could not understand what the male voice was saying. The males he described were seen walking through Lot 25 as Officers were approaching, Officers attempted to locate those males and found them in Lot 13, they stated they were trying to help the reporting party.
